7. IEC Logic Symbol



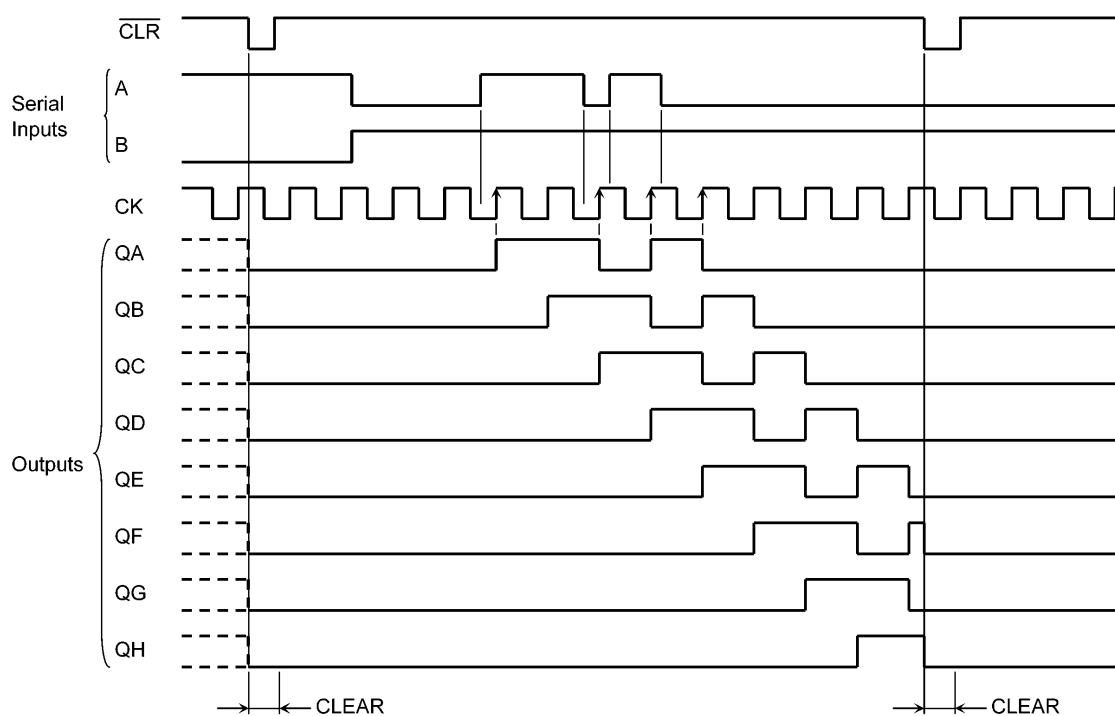

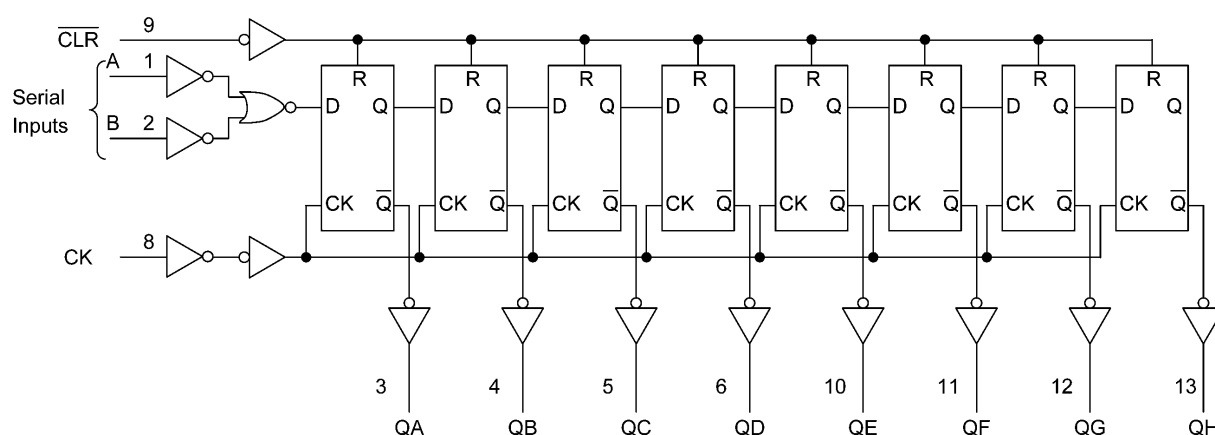

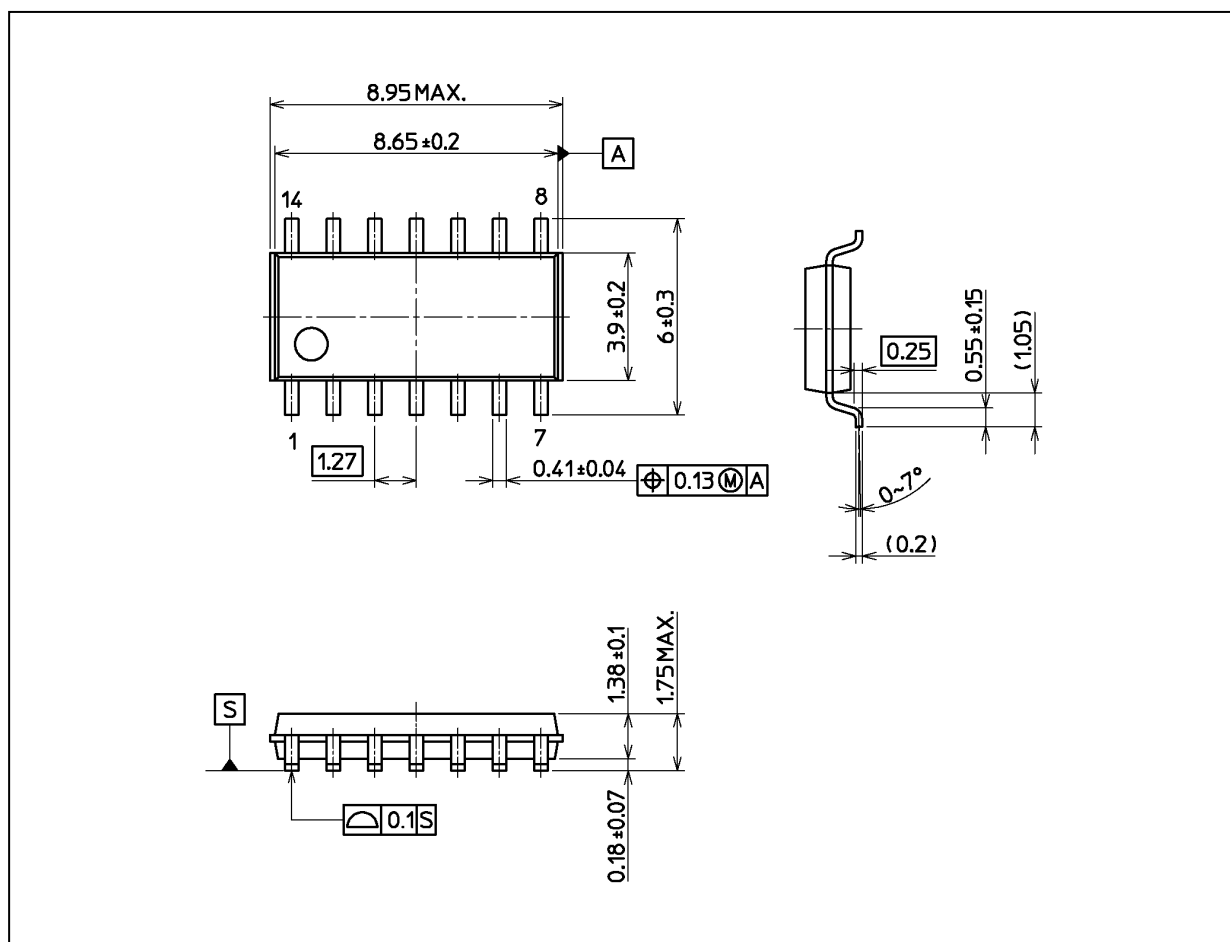
