Figure 1. Average forward power dissipation versus average forward current (per diode)





Figure 3. Relative variation of thermal impedance junction to case versus pulse duration

Figure 2. Average forward current versus ambient temperature ( $\delta$  = 0.5, per diode)




Figure 4. Reverse leakage current versus reverse voltage applied (typical values, per diode)





Figure 6. Forward voltage drop versus forward current (typical values, per diode)




Figure 8. TO-220AB dimension definitions






### Figure 9. D<sup>2</sup>PAK dimension definitions
