


## System Diagram



DIP20-P-300-2.54A Unit: mm

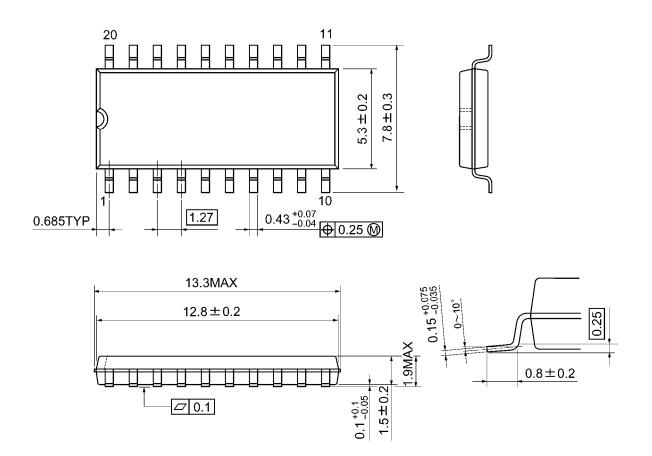
