


Figure 1. Static Characteristic




Figure 3. Collector-Emitter Saturation Voltage




Figure 5. Base-Emitter On Voltage




Figure 2. DC Current Gain





Figure 4. Base-Emitter Saturation Voltage




Figure 7. Current Gain Bandwidth Product




Figure 9. Normalized Transient Thermal Resistance




Figure 8. Power Deration


