# LM336Z5 Programmable Shunt Regulator



## **Description**

The LM336Z5 integrated circuit is precision 5.0 V shunt regulator. The monolithic  $I_{C}$  voltage reference operates as a low temperature coefficient 5.0 V Zener with 0.6  $\Omega$  dynamic impedance. A third terminal on the LM336Z5 allows the reference voltage and temperature coefficient to be trimmed.

The LM336Z5 is useful as a precision 5.0 V low-voltage reference, which makes it convenient to obtain a stable reference from low-voltage supplies. Further, since the LM336Z5 operates as shunt regulator, it can be used as either a positive or negative voltage reference.

## **Block Diagram**




Figure1. Block Diagram




Figure 2. Schematic Diagram




Figure 3. Reverse Characteristics




Figure 4. Temperature Drift




Figure 5. Forward Characteristics




Figure 6. Reverse Voltage Change




Figure 17. 3-Lead, TO-92, Molded, Standard Straight Lead




Figure 18. 3-Lead, TO-92, Molded, 0.200 in Line Spacing Lead Form


