




TEST CIRCUIT 1: IOH Test Circuit




TEST CIRCUIT 3: ICCL Test Circuit




TEST CIRCUIT 2: VOL Test Circuit



TEST CIRCUIT 4: ICCH Test Circuit





TEST CIRCUIT 5: Switching Time Test Circuit

TEST CIRCUIT 6: Common-Mode Transient Immunity Test Circuit






Ambient Temperature Ta (°C)








Figure 2 Tape Forms




Figure 3 Reel Form


