


Figure 1. Typical Pulsed Current Gain vs Collector Current




Figure 2. Collector-Emitter Saturation Voltage vs Collector Current




Figure 3. Base-Emitter Saturation Voltage vs Collector Current




Figure 4. Base-Emitter On Voltage vs Collector Current




Figure 5. Collector Cutoff Current vs Ambient Temperature

## Input and Output Capacitance vs Reverse Bias Voltage




Figure 6. Input and Output Capacitance vs Reverse Bias Voltage




Figure 7. Power Dissipation vs Ambient Temperature
