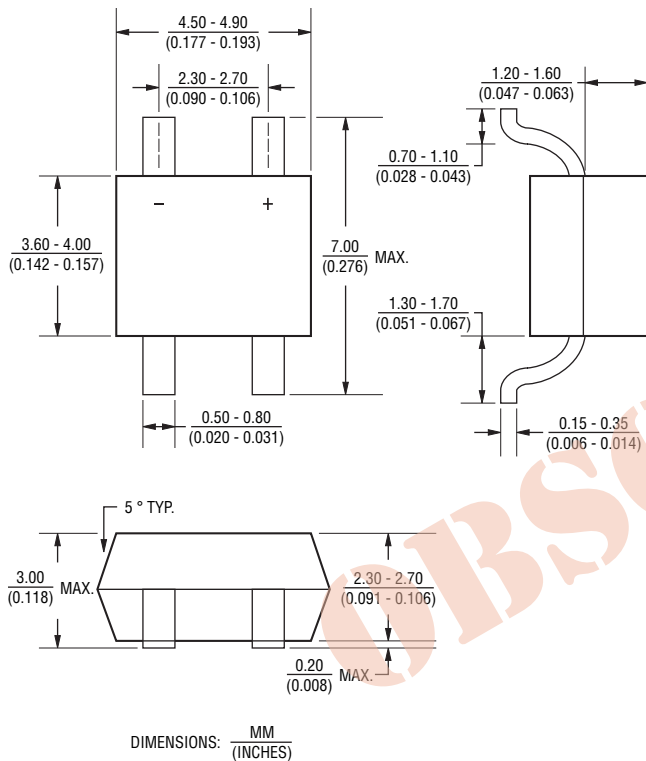

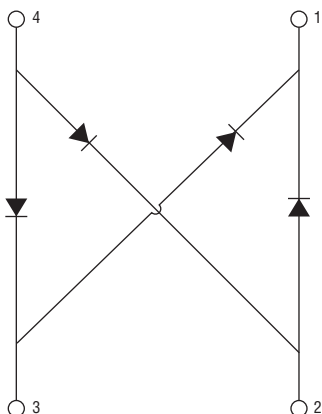
## Product Dimensions

This is a molded package weighs approximately 0.125 g and can be mounted in any position. The dimensions for the packaged device are shown below.



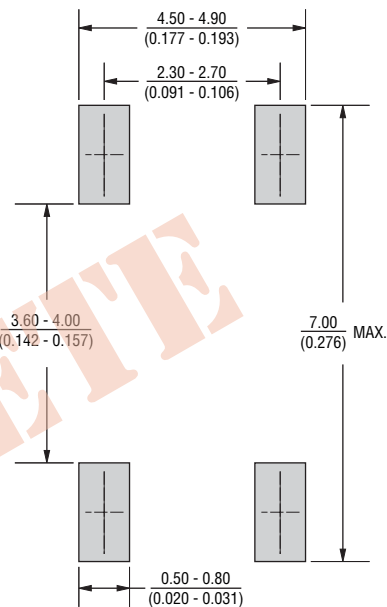
## Block Diagram

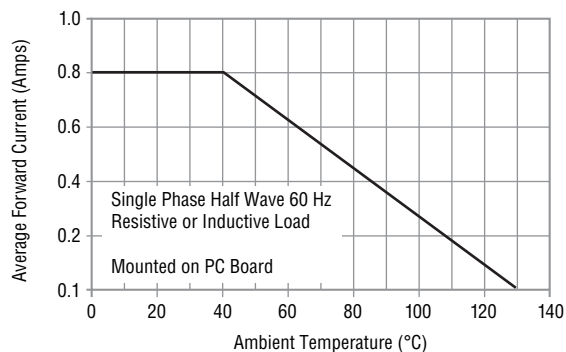

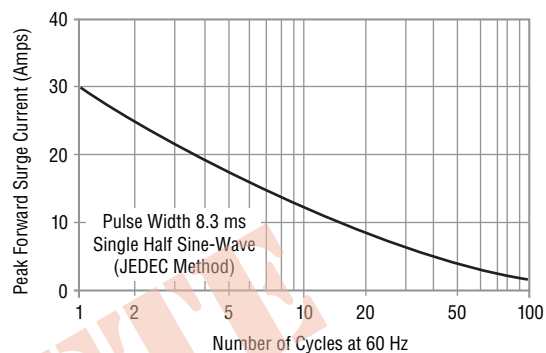

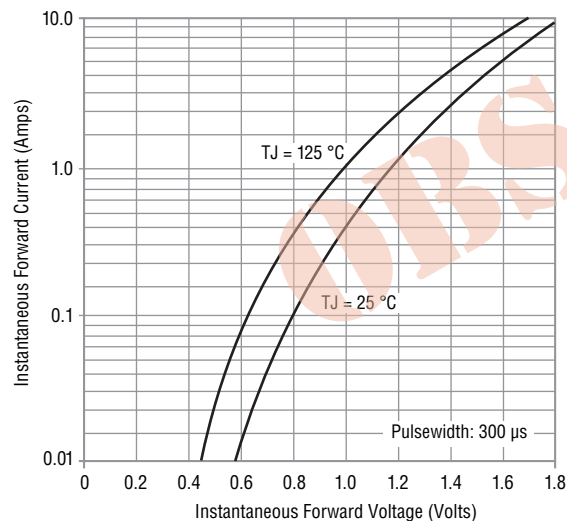
#### Forward Current Derating Curve



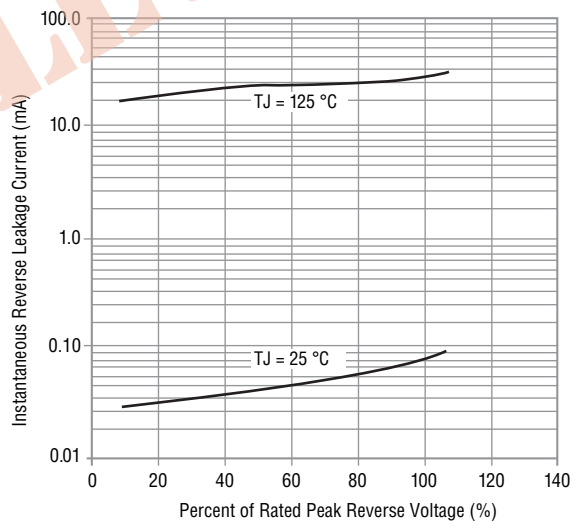
#### Maximum Non-Repetitive Surge Current



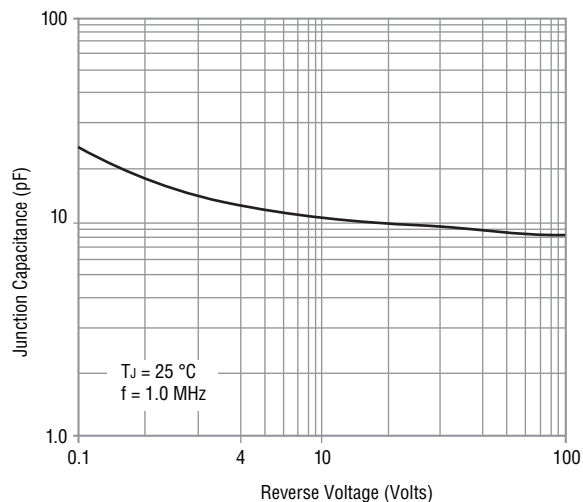
#### Typical Forward Characteristics
