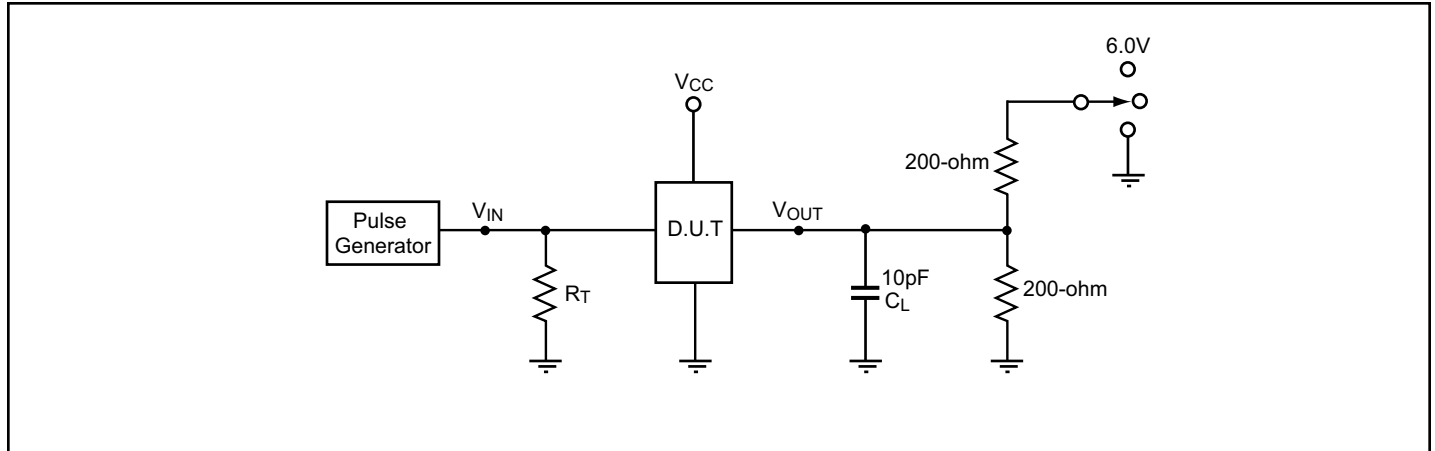

Test Circuit for Electrical Characteristics



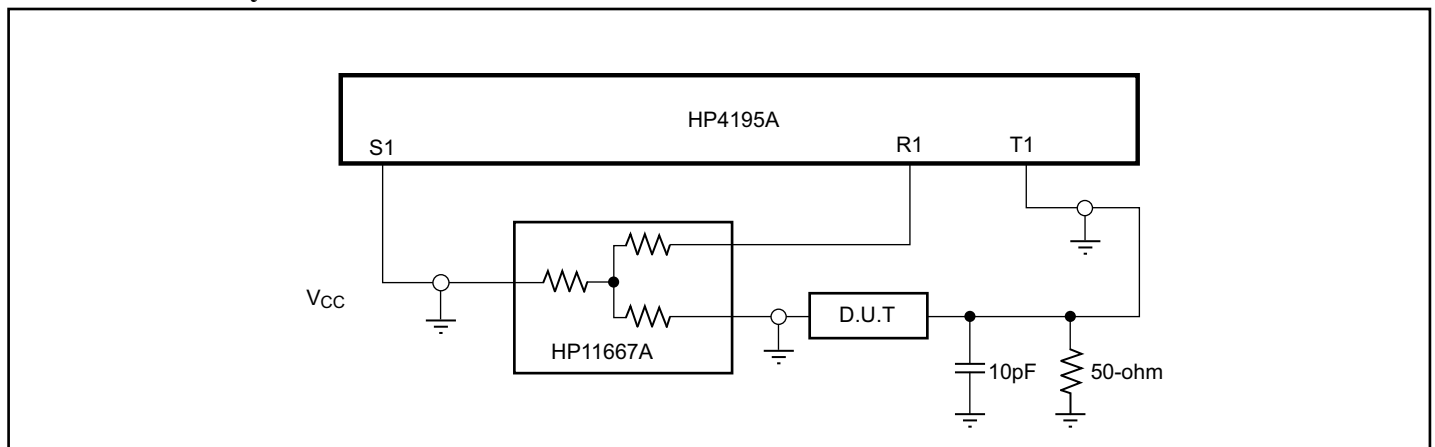

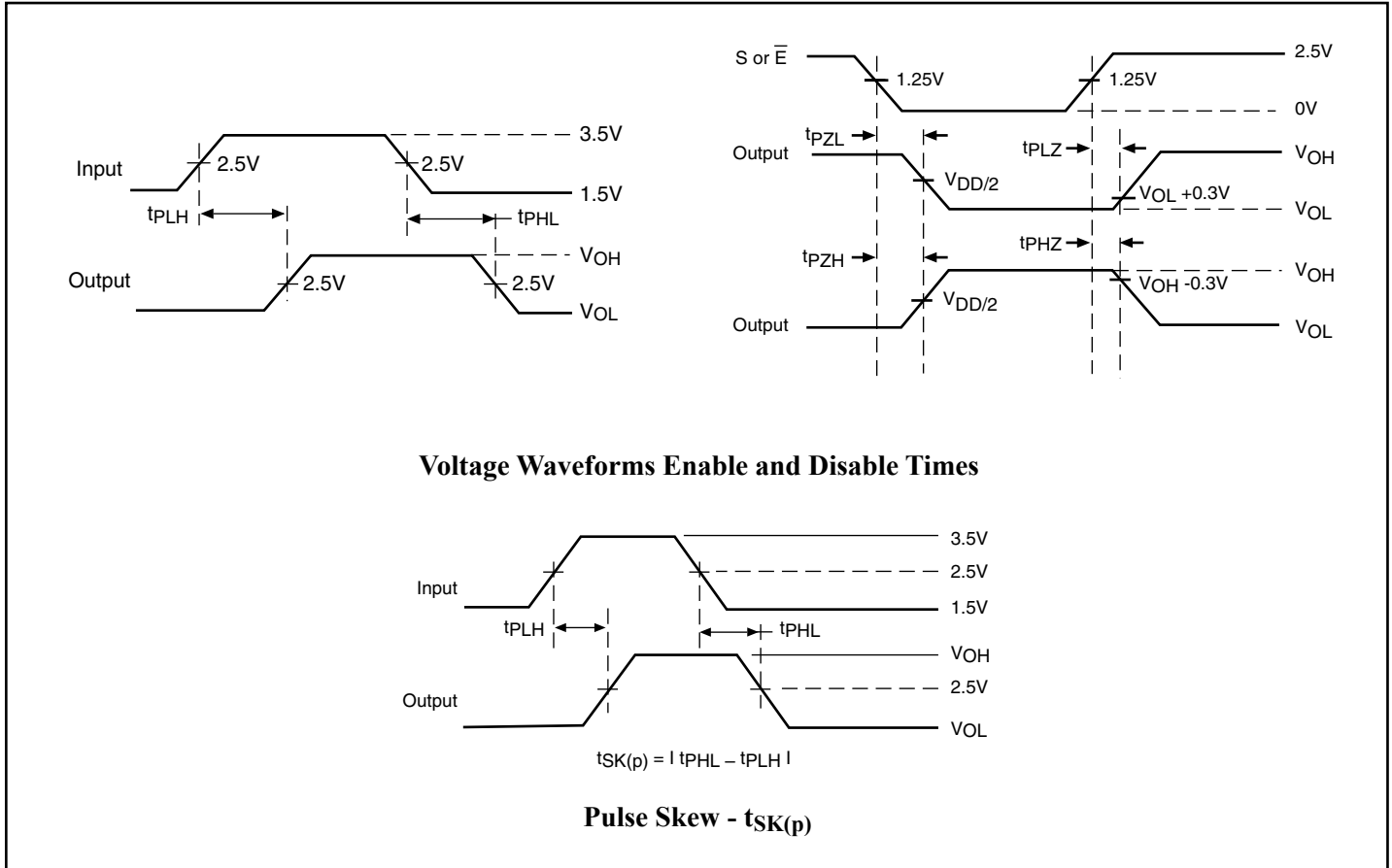

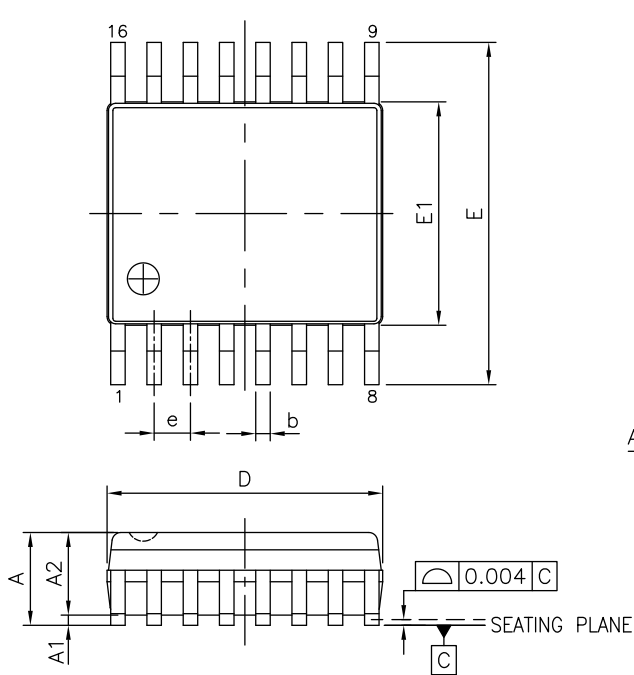
Logic Inputs

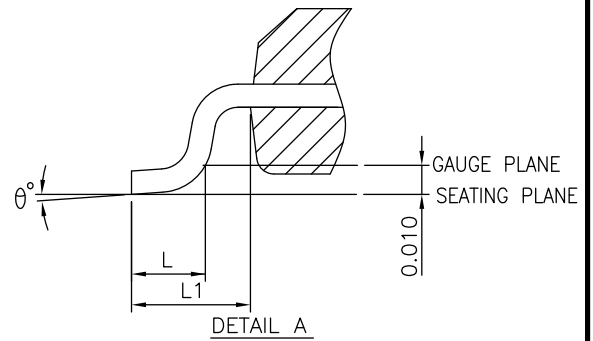
