






Fig. 3 Drain-Source On Resistance vs. Junction Temperature






Fig. 5 Drain-Source On Resistance vs. Drain Current






I_D, DRAIN CURRENT (A)

Fig. 6 Drain-Source On Resistance vs. Drain Current













Fig. 10 Capacitance vs. Drain Source Voltage


