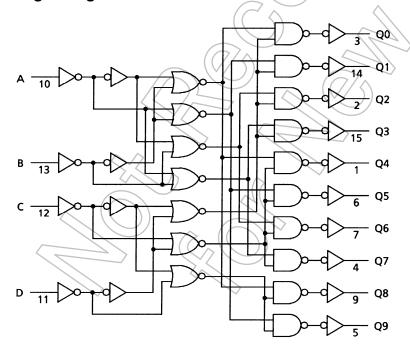

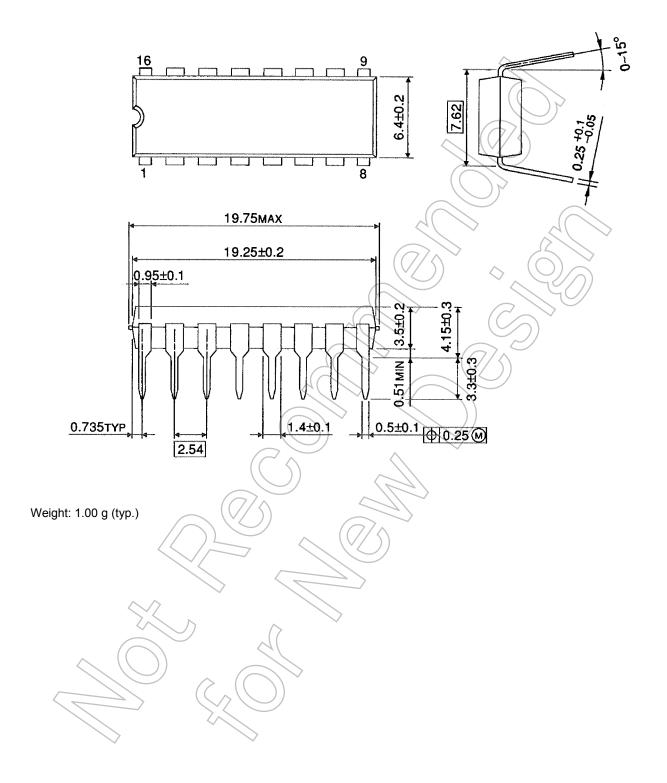
## **Waveform for Measurement of Dynamic Characteristics**

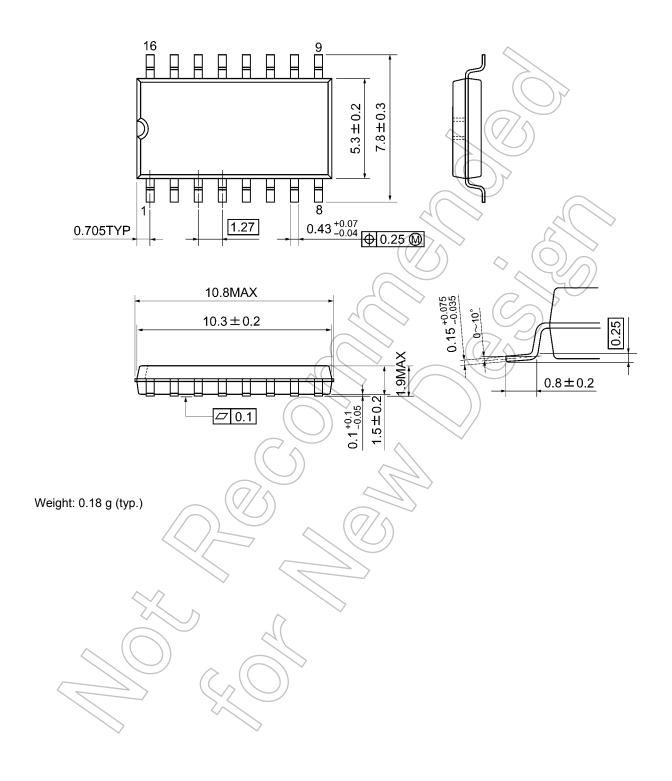
