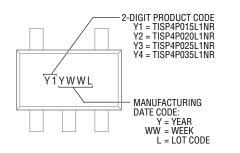

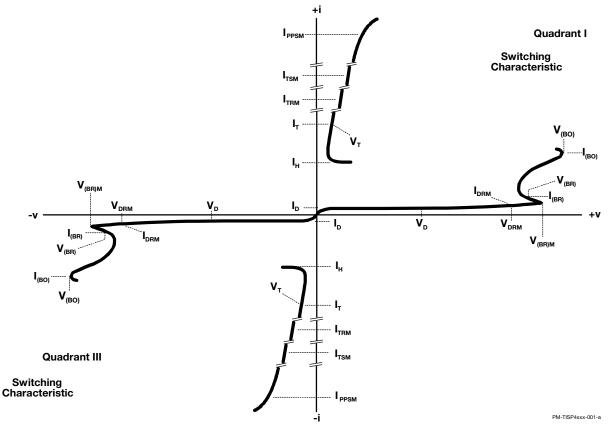
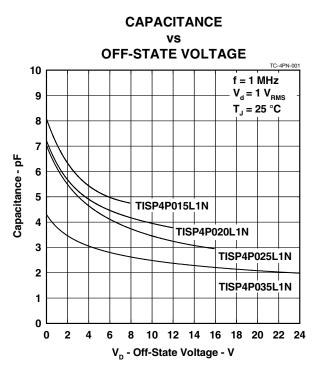


Figure 1. Voltage-Current Characteristic for Tip and Ring Terminals All Measurements are Referenced to the Ring Terminal

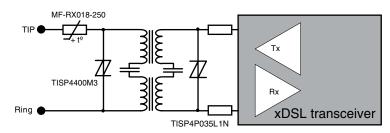

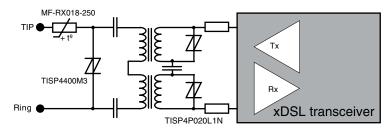

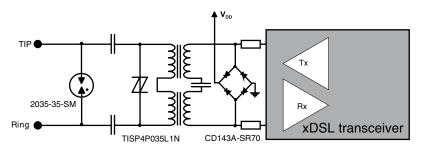
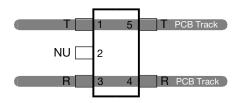
