



# Figure 1. Average forward power dissipation Figure 2. versus average forward current








Figure 4. Relative variation of thermal impedance junction to case versus pulse duration





Figure 5. Reverse leakage current versus reverse voltage applied (typical values)


Figure 6. Junction capacitance versus reverse voltage applied (typical values)



# Figure 7. Forward voltage drop versus forward current







Figure 9. PowerFLAT-3.3x3.3-8L dimensions (definitions)





