










Average Supply Current vs. Supply Voltage




Sleep Mode Time vs. Supply Voltage




B_{OP}/B_{RP} vs. Ambient Temperature



Awake Mode Time vs. Supply Voltage




Power Dissipation vs. Ambient Temperature










Package Outline Dimensions (All dimensions in mm(inch).)








Package Outline Dimensions (cont.) (All dimensions in mm(inch).)

(2) Package Type: SOT-23-3








Package Outline Dimensions (cont.) (All dimensions in mm(inch).)

(3) Package Type: DFN-2×2-3




