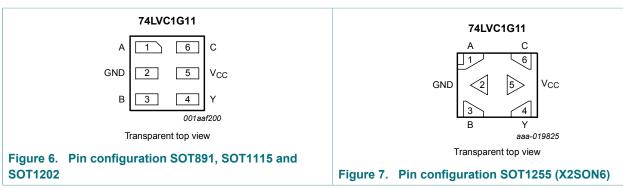

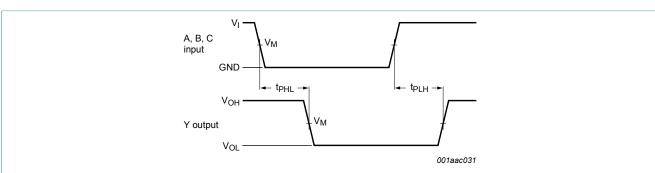

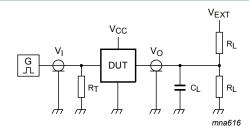

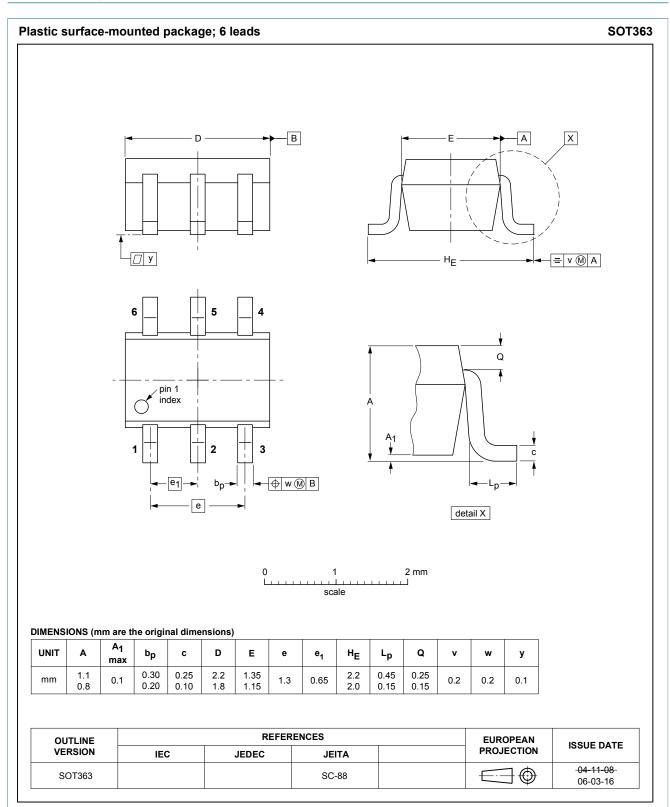
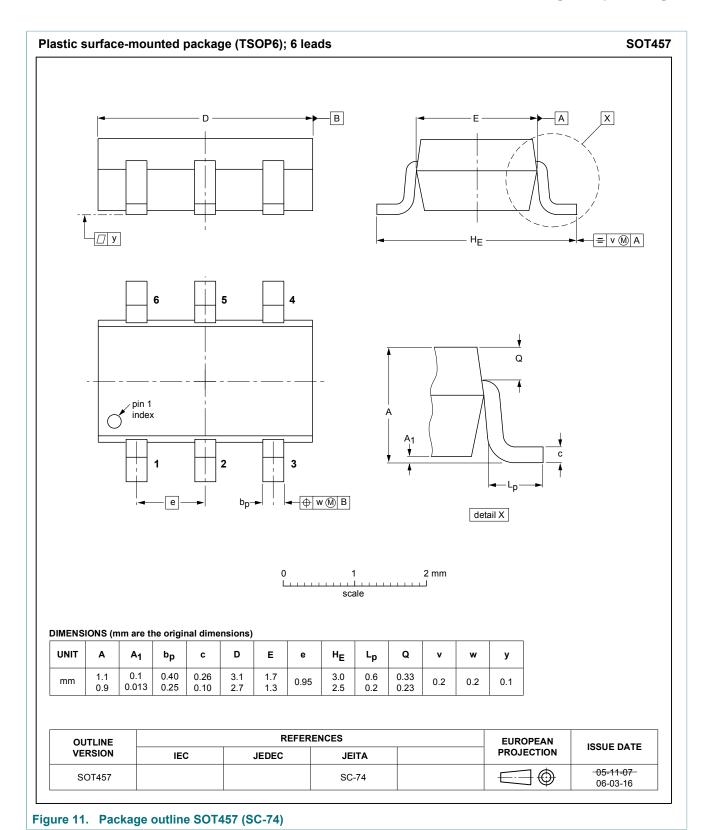
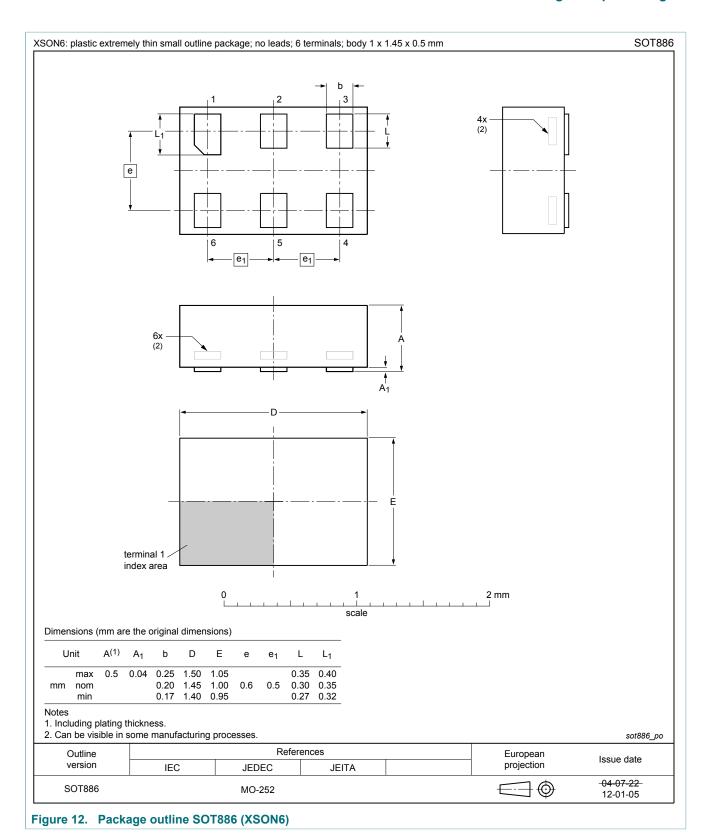


Figure 10. Package outline SOT363 (SC-88)
